### Payment Options:

1. Check, money order, cashier's check (**Family ID must be included on all forms of payment**)
2. Tuition Loan for tuition only, **not fees**. All tuition loans, new or renewal of existing loans, must be applied for prior to 5/6/11 at [www.tuition.fbtonline.com](http://www.tuition.fbtonline.com). If further assistance is needed, please contact the bookkeeper.

Please note our tuition refund policy for student transfers as reflected in the 2010-2011 student handbook. If a student transfers during the school year, tuition paid in advance will be refunded according to the graduated tuition scale as follows:

June. 1 – Sept. 1	50%
Sept. 2 – Oct. 1	45%
Oct. 2 – Nov. 1	40%
Nov. 2 – Dec. 1	35%
Dec. 2 – 15	25%
Dec. 15 – June 1	No Refund
